# Alternative transcription start site usage and functional implications in pathogenic fungi

Abstract: Pathogenic fungi require delicate gene regulation mechanisms to adapt to diverse living 9 environments and escape host immune systems. Recent advances in sequencing technology have 10 exposed the complexity of the fungal genome, thus allowing the gradual disentanglement of multi-11 ple layers of gene expression control. Alternative transcription start site (aTSS) usage, previously 12 reported to be prominent in mammals and to play important roles in physiopathology, is also pre-13 sent in fungi to fine-tune gene expression. Depending on the alteration in their sequences, RNA 14 isoforms arising from aTSSs acquire different characteristics that significantly alter their stability 15 and translational capacity as well as the properties and biologic functions of the resulting proteins. 16 Disrupted control of aTSS usage has been reported to severely impair growth, virulence, and the 17 infectious capacity of pathogenic fungi. Here, we discuss principle concepts, mechanisms, and the 18 functional implication of aTSS usage in fungi. 19

Keywords: Alternative transcription start sites; fungi

#### 1. Introduction

RNA molecules are synthesized in the cell by DNA- or RNA-dependent RNA poly-22 merases and mature through various processes, including splicing, capping, polyadenyl-23 ation, methylation, editing, and endonuclease and/or exonuclease digestion [1]. The nu-24 cleotide sequence of RNA molecules and the region surrounding the corresponding gene 25 locus play critical roles in the control of these processes and significantly influence the 26 transcriptome structure. Typically, eukaryotic RNA polymerase promoters consist of a 27 core promoter and associated regulatory regions [2]. The core promoter can be defined as 28 a genomic region harboring specific sequences that allow the recruitment and assembly 29 of the pre-initiation complex (PIC) and that prime transcription at a basal level or upon 30 stimulating signals [3,4]. Regulatory inputs from cis-acting elements are transduced at the 31 core promoter to regulate RNA synthesis. After the formation of the PIC, the double-32 stranded DNA is melted to create the "transcription bubble" at the core promoter, allow-33 ing 5'-to-3' scanning of RNA polymerase II and transcription initiation at the transcription 34 start site (TSS) [4]. One conserved characteristic is that transcription of a given RNA gen-35 erally does not start at a unique nucleotide position. Rather, TSSs appear to form clusters 36 in which TSS positions are located near one another. This represents the major TSS (mTSS) 37 position, which is the most frequently used location for the initiation of RNA synthesis 38 [4]. Each TSS cluster has a corresponding core promoter that spans the cluster and primes 39 transcription initiation [4]. While core promoters are characterized by elements such as 40the "TATA box", initiator element (Inr), and/or TFIIB recognition element (BRE), gene-41 specific regulatory elements are located upstream of the core promoter and control tran-42 scription [2-5]. 43

The general transcription machinery is highly conserved across eukaryotes. Accordingly, fungi share similarities with mammals, including cofactors, cis-elements that con-45

trol RNA pol II initiation, and other parts of the transcription process [2,3,6–8]. In Saccha-46 romyces cerevisiae, the TATA box is typically located at positions from 40 to 120 bp up-47 stream of the TSS [3,9]. This distance between the TATA box and the TSS seems to be 48 organism-dependent. For example, this distance is shorter in Schizosaccharomyces pombe 49 (40 to 70 bp) [10–13]. Core promoters of genes in many pathogenic fungi, such as Ustilago 50 maydis crg1 and mig2-1 to mig2-6, Nectria haematococca PDA1, and Coprinopsis cinerea clp1, 51 contain a TATA box located around 40 to 46 bp upstream of TSS [14–16]. Likewise, BRE is 52 found in the Magnaporthe grisea MPG1 gene, while analysis of 19 oomycete Phytophthora 53 infestans genes revealed an Inr sequence that is highly similar to that of mammals 54 [14,17,18]. In human fungal pathogens, a genome-wide analysis in Candida glabrata 55 showed that the TATA box exists within the region from 200 to 1 bp upstream of the TSS 56 [19]. In Cryptococcus neoformans and Cryptococcus deneoformans, the TATA box, when pre-57 sent, can be found 35-40 bp upstream of the mTSS (Dang and colleagues, manuscript in 58 preparation). 59

Recently, the analysis of the distance between the TATA box and TSS in 12 yeast 60 species allowed the definition of two classes of transcription initiation mechanisms [20]. 61 The first mechanism, referred to as the "classic model" because it seems to be more wide-62 spread among eukaryotes, involves direct recognition of the TSS from factors recruited to 63 the PIC. The other model, referred to as the scanning model, is based on the recruitment 64 of RNAPII to the PIC, the opening of the transcription bubble, and scanning by RNAPII 65 from the PIC downstream region towards the 3' end to find an acceptable TSS. Candida 66 albicans is more likely to use the scanning model, while Cryptococcus utilizes the classic 67 model of transcription initiation. 68

The historical model of gene expression is that a gene is transcribed into a single 69 mRNA that eventually serves as a template for the synthesis of a functional protein. The 70 Beadle and Tatum "one gene, one enzyme" postulate imprinted the minds of scientists for 71 decades before diverse transcriptional and post-transcriptional diversity was described. 72 The textbook definition of a gene is often given as a transcription unit with one core pro-73 moter; thus, a gene would have only one TSS. However, recent advances in sequencing 74 technology have allowed a closer look at the diversity of RNA molecules, revealing the 75 spectacular plasticity of the eukaryotic transcriptome [21–24]. In mammals, usage of alter-76 native splicing (aSpl),) alternative TSSs (aTSSs), and alternative Poly(A) sites (aPAS) is 77 prominent [25–29]. These processes are developmentally regulated [30], and defects in 78 these processes are associated with a number of genetic diseases, such as thalassemia, ret-79 initis pigmentosa, heart failure, and various types of cancer [31–38]. Interestingly, quanti-80 tative analysis of TSS usage suggested that aTSS and aPAS usage represents a major 81 source of transcript isoform diversity in human tissues [39]. Thus, aTSS usage can have 82 consequences on RNA stability, localization, and coding potential. aSpl, aTSS, and aPAS 83 appear to be common in fungi [40]. However, these processes mostly result in unproduc-84 tive transcripts, which haves a limited impact on proteome diversity and thus the pro-85 cesses function more as a way to regulate gene expression [40–44]. Due to technical diffi-86 culties associated with their study, knowledge on aTSS was, up to recently, restricted to 87 the model yeasts S. cerevisiae and S. pombe. Although less is known in pathogenic fungi, 88 existing data suggest that these mechanisms might contribute into fine-tuning gene ex-89 pression during infection [45-47]. Here, we review recent literature on aTSS usage and 90 regulation and the consequences on fungal biology. We focus on fungal pathogens and 91 discuss the potential and the mostly unexplored consequences of these regulations on vir-92 ulence. 93

#### 2. Identification of alternative transcription start sites

An aTSS is a TSS cluster that differs from the reference TSS most frequently used to initiate RNA synthesis under various environmental conditions. In the scanning model, the PIC may assemble at a single location but initiates transcription at different aTSS clusters [48,49]. For clarity, we will consider aTSS to have a similar meaning to alternative TSS 98

cluster, alternative promoter, or promoter switch, and the term is not related to the heter-99 ogeneity of TSSs within a TSS cluster as mentioned above. More than half of human genes 100 have alternative promoters, and a human gene has an average of 4 TSSs [50]. This implies 101 that a single human gene can harbor multiple core promoters that drive the transcription 102 of RNA polymerase at distinct TSSs. Recently developed techniques, such as CAGE, TIF-103 seq, TL-seq, TSS-seq, and STRIPE-seq, provide insight into the TSS position at a single-104 nucleotide resolution and have confirmed the model of multiple TSS genes in eukaryotes 105 [51–55]. Kimura and colleagues reported that at least 7674 genes, accounting for 52% of 106 total human annotated genes, were regulated by putative alternative promoters [56]. In 107 Drosophila, data from 5' cap read sequencing revealed 34,664 discrete TSS clusters associ-108 ated with 8577 genes, suggesting comparable complexity of aTSS usage in the fruit fly 109 compared to humans [57]. The situation appears to be similar in fungi. For instance, 1773 110 S. pombe genes have at least 2 core promoters [58]. In S. cerevisiae, 56% of the genes have at 111 least 2 TSS clusters, and alternative core promoter usage by a gene is widespread in re-112 sponse to changing environments [59]. Nevertheless, information about aTSS usage in 113 pathogenic fungi is limited due to both the scarcity of genome-wide studies and caveats 114 in data integration. Results from 5'-end-cDNA sequencing of C. glabrata showed that out 115 of 4316 coding genes, only 10% (n = 435) were transcribed from a single TSS, but it is un-116 clear as to how many TSS clusters these TSSs belong [19]. A study in Aspergillus nidulans 117 grouped 18,817,969 TSS positions into 17,992 putative TSS clusters, but further analysis of 118 alternative usage of these clusters in various growth conditions has yet to be conducted 119 [60]. Nonetheless, evidence of aTSS usage in pathogenic and non-pathogenic fungi has 120 been published. In Neurospora crassa, the TSS positions of the circadian clock gene frq are 121 distributed into two alternative major clusters depending on light exposure of the fungus 122 [61]. In C. neoformans, aTSS usage results in the production of two alternative isoforms of 123 PUM1 regulated by sexual development growth phase [62]. Our recent TSS-seq data anal-124 ysis in two Cryptococcus species revealed the existence of more TSS clusters than coding 125 genes, suggesting widespread aTSS usage in these pathogenic yeasts [63]. While global 126 studies will provide more understanding of the extent and dynamics of aTSS usage in 127 various fungal species, the biological functions and mechanism of aTSS in pathogenic 128 fungi is of particular interest. 129

#### 3. Biological consequences of aTSS in fungi

During the 2000s, promoter switching events associated with mammalian development and disease etiology have been the subject of reviews that have cited results from hundreds of studies [64–67]. aTSS usage is expected to have a similar impact on the fungal transcriptome and proteome. Although aTSS likely affects lncRNAs in addition to mRNAs, we focus on mRNAs and discuss the consequences of aTSS usage on fungal mRNA level, mRNA diversity, and proteome diversity. 131 132 133 134 135

#### 3.1. Alternative transcript isoforms share the same ORF but differ in leader (5'UTR) sequence

aTSSs can be found upstream or downstream of the annotated TSS, which modulates 138 the 5'UTR length. This modulation can result in the inclusion or exclusion of sequences 139 containing important regulatory elements (Figure 1). For instance, the presence of one or 140 more upstream open-reading frames (uORFs) within this region can dramatically alter 141 mRNA stability and translation efficiency. In mammals, an uORF-linked regulatory mech-142 anism has been illustrated in the mouse with the cyclin-dependent kinase inhibitor 143 (p18INK4c) and peroxisome proliferator-activated receptor (PPAR) beta/delta [68,69]. In 144 S. cerevisiae, 791 mRNAs contain uORFs in their transcript leader sequence [70], and 252 145 genes contain conserved uORFs [71]. Although the function of most uORFs has not been 146 explored in detail, examples of uORF-dependent-regulation associated with alternative 147 TSS usage exist. For instance, alternative promoter usage of the NDC80 gene produces 148 either a nonfunctional long transcript bearing several uORFs or a short translatable 149

mRNA, allowing versatile management of protein expression [72]. The NDC80 gene en-150 codes a subunit of the outer kinetochore, which plays a key role in meiosis. The controlled 151 expression of two NDC80 mRNA isoforms are responsible for the inactivation and reacti-152 vation of the kinetochore during cell division through Ndc80 protein level. The translata-153 ble short isoform is highly expressed in vegetative growth, but at the beginning of meiosis, 154 100% of cells express only the nonfunctional long isoform, which harbors 9 uORFs. Hence, 155 no Ndc80 protein is produced at the meiotic prophase, thereby ensuring proper removal 156 of the kinetochore at this stage. Mutating all 9 AUGs led to an increase in Ndc80 protein 157 during prophase, confirming the inhibitory effect of uORFs on the translation of the main 158 coding sequence. This abnormal expression of NDC80 from the mutated long mRNA iso-159 form led to abnormal chromosome segregation during cell division. In pathogenic fungi, 160 uORFs in the 5'UTR contribute to the control of translation and RNA stability in response 161 to environmental cues [73,74]. In C. neoformans, a robust, transient transcriptome modifi-162 cation is triggered upon exposure to reactive oxygen species [75], which is explained by 163 translation inhibition through Gcn2-mediated eIF2 $\alpha$  phosphorylation [73]. This likely fa-164 vors the efficient translation of the oxidative stress response gene ERG110 and GCN4, 165 which both contain uORFs in the transcript leader (TL) of their mRNA [73,76]. In addition, 166 the production of an alternative transcript isoform containing an uORF has been reported 167 for the Metarhizium robertsii Mr-OPY2 gene [43]. The plant- and fly-infecting fungus M. 168 robertsii requires precise regulation of the Mr-OPY2 membrane anchor protein during sap-169 rophyte-to-insect pathogen transition. During saprophytic growth, Mr-OPY2 mRNA con-170 tains 2 uORFs that impede the translation of the main coding sequence. The elevated level 171 of Mr-OPY2 protein during infection stages is achieved through the production of a short 172 mRNA isoform that does not contain the 2 uORFs. Mutant strains that fail to express Mr-173 OPY2 proteins were impaired in appressorial formation and infection capacity. Artificial 174 constitutive expression of the major open reading frame (ORF) during saprophytic growth 175 results in the fluffy phenotype, aberrant conidiophores, and significantly reduced conidial 176 production. These findings illustrate that aTSS- and uORF-associated regulatory strate-177 gies are exploited by both fungi and mammals as a flexible tool to regulate protein levels. 178

Genome-wide data analyses of TL structure performed in Saccharomyces, Cryptococ-179 cus, Aspergillus, Candida, and Neurospora species confirmed the repressive effect of uORFs 180 on translation efficiency [53,60,63,77]. The translation efficiency of annotated ORFs is neg-181 atively correlated with the number of uORFs present in the 5'UTR. This is in agreement 182 with the observation in mouse fibroblasts that uORF-containing longer mRNA isoforms 183 are enriched in the monosome fraction, which is indicative of a lack of translation of the 184 main ORF [78]. Analysis of Ribo-seq data revealed some examples of such regulation in 185 Cryptococcus. At the CNAG\_06246 and CNAG\_03140 loci, only uORF translation was ob-186 served in the tested conditions, whereas the main ORF translation was completely abol-187 ished, suggesting tight regulation of gene expression [63]. 188

Although the general view is that uORF translation would eventually trigger mRNA 189 to degrade via nonsense-mediated mRNA decay (NMD), as suggested in Cryptococcus and 190 S. cerevisiae [53,63], some uORF-based regulation appears to be more complex [79]. A clas-191 sic example is the S. cerevisiae GCN4 gene, which has 4 small uORFs in the 5' leader se-192 quence of its mRNA [80]. In amino acid-rich media, ribosomes are dissociated after pass-193 ing a GC-rich region at the end of the fourth uORF within GCN4 mRNA. Therefore, ribo-194 some re-initiation scanning is hindered after translation of the fourth uORF, and no pro-195 tein is synthesized from the main ORF. 196

Given the small length of uORF-born peptides, one question is whether these short 197 peptides possess any biological function. Examples of functional small peptides (<100 198 amino acids in length) are available in vertebrates and *Drosophila* [81]. In fungi, *N. crassa* 199 arg-2 mRNA contains an evolutionarily conserved uORF coding a 24-amino acid peptide 200 called arginine attenuator peptide (AAP), which participates in the control of ribosome 201 movement [82]. Nevertheless, the features of repressive uORFs are evolutionarily maintained rather than their amino acid sequence [83]. This suggests that conserved uORFs are 203 mostly involved in regulation of translation of the downstream major ORF rather than 204 encoding functional protein [84]. 205

A longer 5' leader sequence of transcripts resulting from an upstream aTSS can po-206 tentially form a secondary structure that interferes with translation initiation [85]. Once 207 assembled, the 43S complex scans the TL sequence to identify the correct translation start 208 site [86]. Though the ribosome has the ability to process helicase activity, RNA secondary 209 structures, such as the stem-loop hairpin structure, can block translation initiation via 210 blockage of the scanning process [87,88]. For instance, under hypoxic conditions, S. pombe 211 transcribes a translationally silent transcript from an upstream promoter at the TCO1 lo-212 cus [89]. The additional 751-nucleotide sequence of this alternative transcript is computa-213 tionally predicted to form a stable stem-loop structure thought to block translation initia-214 tion by impairing 43S scanning. 215

Additional cis-regulatory sequences included within the 5' leader sequence upon 216 aTSS usage can alter mRNA translation potential. An interesting example is the Pumilio 217 protein family PUM1 gene in C. neoformans [62]. Pum1 is an RNA-binding protein re-218 quired for hyphal formation and is known to indirectly enhance the mRNA stability of 219 the master filamentation regulator Znf2 [90]. In yeast cells, the Pum1 protein binds to its 220 own transcript leader sequence, blocking ribosome scanning and shutting off mRNA 221 translation [62]. In filaments, C. neoformans utilizes an alternative downstream TSS to pro-222 duce a shorter isoform lacking the Pum1 binding site [62]. Thus, aTSS usage prevents auto-223 inhibition, thereby allowing full expression of PUM1 and activation of ZNF2. 224

#### 3.2. Alternative transcripts are translated into N- termini-truncated proteins

Although aTSS usage maintains an intact ORF in 60% to 80% of studied cases in mammals, it can also be a source of proteome diversity [65]. Thus, the usage of TSS clusters 232 within coding sequences potentially results in novel protein isoforms. The translationally 233 active downstream ATG (dATG) is typically found in-frame with the annotated ATG 234 (aATG), so the alternative protein is a N-terminus–truncated version of the annotated one. 235 This shorter polypeptide can maintain the same functional domains but lacks sequences 236

critical for protein localization (Figure 2). For instance, the plant Arabidopsis thaliana grow-237 ing in shaded conditions uses aTSS to produce a cytosolic isoform of GLYK, a photorespi-238 ration enzyme believed to solely reside in the chloroplast [91]. Such aTSS regulation of 239 protein localization by N-terminus truncation has been described for some S. cerevisiae 240 tRNA synthetase genes. In these examples, instead of having a dedicated gene for cyto-241 solic and mitochondrial tRNA-synthetase, a single gene generates both enzymes [92]. Both 242 cytoplasmic and mitochondrial versions of histidinyl, valinyl, and cysteinyl tRNA synthe-243 tases are encoded by a single gene (HST1, VAS1 and CRS1, respectively) [92-94]. At these 244 loci, aTSSs generate either a long or short transcript isoform leading to alternative protein 245 versions of Hts1, Vas1, and Crs1. The truncated versions lack the mitochondria targeting 246 signal (MTS) at the N terminus and remain in the cytosol, while the full-length versions 247 are translocated into the mitochondria. In the fungal pathogen C. neoformans, both tRNA 248 synthetase activities are encoded by a single gene for most amino acids [63]. The expres-249 sion of the 2 protein isoforms can be controlled by aTSS usage to produce a long and a 250 short transcript, and the long isoform can produce both cytosolic and mitochondrial en-251 zymes. Another layer of regulation is the selection of the translation initiation position, 252 which is based on the consensus level of the associated Kozac context of the long transcript 253 [63]. However, aTSS-dependent protein localization has been reported for other C. neofor-254 mans genes. For instance, C. neoformans synthesizes a long UVE1 mRNA isoform which 255 codes a protein, following UV exposure, specifically targeted to the mitochondria [95]. 256 This long Uve1 protein is functionally active as a DNA damage repair endonuclease and 257 protects the mitochondrial genome from potentially lethal UV-induced DNA damage. 258 Similarly, C. neoformans employs aTSSs as a novel layer of regulation of superoxide dis-259 mutase activities. The genes SOD1 and SOD2 encode genes with cytoplasmic Cu-depend-260 ent and mitochondrial manganese-dependent superoxide dismutase activities, respec-261 tively [96]. Upon Cu shortage, an aTSS is used to regulate both gene products: a transla-262 tionally repressed SOD1 mRNA is produced while a shorter version of SOD2 mRNA pro-263 duces a functional cytosolic version of manganese-dependent superoxide dismutase Sod2. 264 Thus, during infection, a condition in which copper is limited in host cells, the Cryptococ-265 cus manganese-dependent superoxide dismutase typically located in the mitochondria is 266 translocated to the cytosol to maintain the cytosolic redox equilibrium against oxidative 267 stress [96]. TSS switch-driven subcellular localization of proteins is not restricted to mito-268 chondrial and cytosolic targeting. For instance, aTSS usage regulates the alternative pro-269 duction of the secreted, glycosylated version of the S. cerevisiae invertase SUC2 in glucose-270 rich culture instead of its constitutive intracellular, non-glycosylated form [97]. 271

This mRNA is275translated into a protein with a localization target signal (mitochondria targeting signal [MTS] in276this example) at its N terminus. The protein is targeted to the mitochondria. Alternative transcription initiation can be used to produce a shorter protein that loses 280 important functional domains (apart from the localization signal) and in turn acts as an 281 inhibitor of its full-length counterpart (Figure 3). An example in fungi is the ZEB2 gene of 282 the cereal- infecting fungus Fusarium graminearum in which aTSS not only impacts protein 283 localization but also alters its function [98]. The full-length Zeb2 protein (Zeb2L) localizes 284 exclusively to the nucleus. This long isoform has a basic leucine zipper (bZIP) DNA-bind-285 ing domain and functions as a transcription factor that induces the production the polyke-286 tide mycotoxin zearalenone (ZEA), a chemical compound leading to hyperestrogenic syn-287 drome in infected cereals. ZEA accumulation triggers the synthesis of an N-terminally 288 truncated protein (Zeb2S) that lacks the bZIP domain and exists in both the nucleus and 289 cytoplasm. The short isoform forms heterodimers with Zeb2L and thus impedes the DNA-290 binding activity of Zeb2L in an autoregulatory process [98]. Similarly, in S. pombe wtf 291 genes encode killer meiotic drivers which are selfish DNA sequence. Interestingly, the wtf 292 drivers use alternative TSS to produce two protein isoforms [99]. Here, the long protein 293 isoform Wtf4<sup>antidote</sup> neutralizes the short protein isoform Wtf4<sup>poison</sup> via heterodimerization. 294 Moreover, the expression of both isoforms is tightly controlled in timing and localization 295 to give the driver a transmission advantage into the next generation [99]. 296

The resulting protein does not contain301the functional domain and might function as an inhibitor of the full-length protein, as in the case of302the Fusarium graminearum protein Zeb2.303

aTSS can result in the production of alternative protein isoforms encoded by alterna-304 tive ORFs. To our knowledge, there are only 2 characterized examples in mammals: cy-305 clin-dependent kinase inhibitor 2A gene (CDKN2A) and p21 in humans [100,101]. Each 306 encodes 2 protein isoforms with different reading frames resulting from an alternative 307 promoter coupled with different splicing patterns. Until recently, reports of similar aTSS-308 induced out-of-frame proteins have been unavailable in fungi. However, genome-wide 309 proteomics approaches that sequence the N-terminal peptide have enabled studies on the 310 impact on the proteome and the discovery of out-of-frame peptides [102–104]. These pu-311 tative detected out-of-frame peptides are clearly not degradation products of annotated 312 proteins that have a different reading frame. Rather, they likely result from bona fide pro-313 teins that are translated starting from an out-of-frame dATG or an in-frame dATG in the 314 presence of alternative splicing. It is likely that such alternative proteins exist in patho-315 genic fungi, but their impact on the biology and virulence of these organisms remains to 316 be studied. 317

#### 3.3. Transcript isoforms are similar in coding sequence and translational efficiency

In some cases, aTSS usage does not impact protein output or translation efficiency 319 (Figure 4). Possible explanations of multiple promoters for essential genes include to en-320 sure expression level regardless of diverse initiation environments, such as the available 321 transcription factor pool, or to diminish the fatal effects of mutations within the promoter 322 [66]. For example, in the fungus Aspergillus oryzae, most glycolysis-reversible enzyme-cod-323 ing genes have multiple TSSs even though they are constitutively expressed [105]. Carbon 324 source-dependent aTSS usage is only observed in two genes: those encoding enolase 325 (enoA) and fructose-bisphosphate aldolase (fbaA), where 2 promoters are alternatively 326 used in response to nutritional signals. Thus, with the exceptions of enoA and fbaA, the 327 existence of multiple TSSs in other glycolysis/gluconeogenesis genes probably functions 328

to maintain a constant level of protein in any environmental condition. On the other hand, 329 enoA is an interesting case because the use of the two promoters depends on the carbon 330 source. This gene is transcribed into two mRNAs that differ only in the 5'UTR; the short 331 isoform is specific to glycolytic conditions, and the long transcript is highly expressed in 332 gluconeogenic conditions. Replacing the 5'UTR of one enoA mRNA isoform with another 333 5' UTR of the reporter gene does not alter translational activity. However, mutations abol-334 ishing transcription from the upstream TSS prevent cell growth in acetate, while transcrip-335 tion from the downstream TSS is important for cell proliferation in glucose. Thus, A. oryzae 336 requires transcription of enoA from distinct TSS/promoters for environmental adaptation, 337 but no clear functional differences between the two mRNA isoforms can be observed. 338 Here, A. oryzae might use aTSSs to adapt to the different availability of some transcription 339 factors so as to satisfy the different demands of an important reversible enzyme in glycol-340 ysis and gluconeogenesis. 341



Figure 4. Alternative transcript isoforms code identical proteins and possess the same translation343capacity. Condition 1: Canonical mRNA from TSS1 is produced. Condition 2: Alternative mRNA344from TSS2 is transcribed. The alternative TSS results in transcript isoforms that differ in the 5' UTR345but have the same coding sequence. This alternative isoform does not significantly impact stability346or translational efficiency.347

#### 4. Mechanism of alternative TSS usage control

As discussed in examples above, some transcripts produced from alternative TSSs 349 are functional and critical to the cell. Fungi actively control their synthesis by employing 350 both cis-elements and trans-factors to accurately produce the correct mRNA isoforms at the correct time. 352

#### 4.1. Transcription factors regulate alternative TSS usage

Transcription can be initiated from aTSS via binding of transcription factors (TFs) to its dedicated promoter, with evidence available both in mammals and yeasts. The promoter switch of the rodent gene satb1 during T-cell development is controlled by the transcription factor TCF1 [85]. In *S. pombe*, transcription from the upstream aTSS of the tco1+ gene in hypoxic conditions is triggered by the oxygen-sensitive TF Sre1 [89]. *S. cerevisiae* Gcn4 is a striking example of a TF that induces unconventional transcription: 546 Gcn4 ChIP-seq peaks were enriched during amino acid starvation vs control nutrient-rich me-

dia. Nearly 60% of Gcn4 genic binding sites are not located at the canonical promoter re-361 gion, but rather are found inside coding sequences (CDSs) [106]. Many of these Gcn4 sig-362 nals within CDSs are adjacent to induced TATA-binding protein peaks, suggesting the 363 existence of cryptic internal promoters. Indeed, Gcn4 binds to its site within the ORF of 364 POS1, SNX41, SPO21, and COG1 and induces both the noncanonical antisense and sense 365 transcriptions starting around 100 bp upstream or downstream. The H3 histone occu-366 pancy profile suggests that Gcn4 does not bind to the pre-existing nucleosome-depleted 367 region. Rather, Gcn4 binding is more likely to stimulate gentle histone removal at the sur-368 rounding region, suggesting that Gcn4 actively provokes transcription initiation. This im-369 plies active regulatory activities of Gcn4 on aTSS usage. 370

TFs function not only as inducers but also as repressors of alternative promoters. 371 Examples in mammals include the transcription factor Chx10, which negatively regulates 372 the synthesis of the 2 transcript isoforms (H- and D-Mitf), but not 8 other isoforms of MIFT 373 gene, in the retina during murine eye development [107]. Examples of TFs that negatively 374 control the transcription of a particular alternative mRNA isoform have yet to be discov-375 ered in yeast. However, S. cerevisiae transcription factor Rap1 is reported to bind at the 376 promoters of highly expressed genes and repress pervasive transcription from these pro-377 moters, possibly by contributing to nucleosome positioning [108,109]. 378

TFs are reported to mediate feedback regulation on aTSS usage at their encoding 379 gene. In humans, the pluripotent stem cell transcription factor NANOG binds to and autoupregulates the usage of its own proximal promoter [110]. In *C. neoformans*, the RNAbinding protein Pum1 autoregulates the expression of its encoding gene by binding *ZNF2* 382 mRNA, thus regulating the expression of this TF [62]. In turn, Znf2p binds to the *PUM1* 383 proximal promoter, inducing the synthesis of a short isoform that lacks the sequence required for translational repression as in the long isoform [62]. 385

Identification of the TFs regulating aTSS usage is suggested by the analysis of the 386 sequence surrounding these TSSs and confirmed through genetic and/or ChIP-based anal-387 yses [85,111,112]. For instance, the binding site of 2 TFs in A. oryzae (AcuK and AcuM) are 388 detected at the upstream promoter of the enoA gene, suggesting that these TFs could reg-389 ulate the expression of the long transcript of the enoA gene in glucose starvation condi-390 tions. Accordingly, mutating the potential binding motif of AcuK and AcuM at the up-391 stream promoter of the enoA gene reduces expression of the long transcript in acetate 392 culture conditions but not in glucose-rich conditions [105]. 393

Some TFs can affect aTSS usage of multiple genes, as observed in mammals and 394 plants [91,113]. In S. cerevisiae, the TFs Ume6 and Ime1 form a heterodimer to activate 395 transcription from alternative promoters upstream of meiotic genes specifically during 396 meiotic prophase. This allows the downregulation of these meiotic specific genes through 397 the combined act of translational and transcriptional repression. Thus, the production of 398 5' extended transcripts down-regulates the expression of the short isoforms through tran-399 scriptional interference of the downstream promoters. Whereas, these long mRNA 400 isoforms are enriched in uORFs, leading to translational repression of the main ORF [114]. 401 Accordingly, Ume6 binding sites are highly enriched at the promoter of these non-canon-402 ical transcripts. Similarly, Gcn4 likely functions as the master regulator controlling the use 403 of a number of aTSSs at different loci in response to amino acid limitation [106]. In addi-404 tion, Zap1 regulates aTSS usage at the RTC4 and RAD27 loci through zinc-responsive el-405 ements (ZREs) [115]. In C. neoformans, the TF Cuf1 controls aTSS usage at the SOD1 and 406 SOD2 loci via Cu-responsive elements (CuREs) [96]. 407

#### 4.2. cis regulatory transcription activity and chromatin conformation remodeling control alternative transcription

Either alternative promoters are independently activated by different pathways via 411 distinct transcription factors, or their usages are intertwined with each other through transcriptional interference. In *S. cerevisiae*, transcription through a promoter can impede its 413 activity [72,116] (Figure 5). For instance, transcription of the short functional *NDC80* 414

mRNA isoform is inhibited by the transcription event starting upstream that generates a 415 5' extended isoform [72]. This repression likely results from co-transcriptional chromatin 416 remodeling [117,118]. During transcription from the upstream TSS of NDC80, the histone 417 methyl transferases Set1 and Set2 regulate H3 lysine 4 dimethylation (H3K4me2) and H3 418 lysine 36 trimethylation (H3K36me3) levels, respectively [119]. Global mapping of epige-419 netic imprinting showed that H3K36me3 and, to a lesser extent, H3K4me2 are strong pre-420 dictors of transcription repression mediated by upstream transcription [114]. The repres-421 sive histone marks H3K4me2 and H3K36me3 are read by histone deacetylases Set3 and 422 Rpd3S, respectively, to promote histone deacetylation at these regions [119]. Histone 423 deacetylation enhances the electrostatic interaction between histones and DNA, thus pro-424 moting nucleosome occupancy and inhibiting local transcription initiation [120]. Tran-425 scription activity from upstream TSSs is likely associated with low-level histone acetyla-426 tion followed by a tighter wrapping of the histone core by the DNA string at the gene 427 body. The converse can be true, where limited upstream transcription activity brings 428 about permissive histone marks at the gene body, thereby allowing downstream tran-429 scription. For instance, low transcriptional activity of S. cerevisiae lncRNA IRT2 induces 430 the acetylation of histone H3 lysine 56 (H3K56ac). The associated relaxed chromatin con-431 formation allows binding of the TF Rme1 at the promoter of lncRNA IRT1, which is lo-432 cated downstream and facilitates its transcription [121]. However, not every gene express-433 ing 5' extended transcripts is associated with a reduction in the abundance of the short 434 transcripts [114]. Further, the effect of expressing distal promoters on proximal ones can 435 range from repression to activation [122]. Interestingly, this effect appears to be dependent 436 on the distance between the distal and proximal TSS. Enhanced transcription from the 437 upstream TSS can repress transcription from the downstream TSS if located more than 80 438 bp from one another, while a smaller distance is linked to positive correlation of their 439 usage [122]. It is possible that a downstream TSS distantly separated from the upstream 440 TSS is likely to have its own promoter, so its activity is regulated by transcriptional inter-441 ference. Nevertheless, this cis regulation through transcriptional interference of aTSS us-442 age remains to be described in pathogenic fungi. 443



Figure 5. Regulatory action in cis and chromatin conformation control alternative transcription.445Condition 1: There is no transcription from TSS1. Acetylated histones (orange circle) at the gene446body downstream TSS1 are associated with a relaxed chromatin state. The transcription factor Y,447which activates transcription at the TSS2, can bind. Condition 2: Transcription from TSS1 leads to448histone deacetylation. This reduction in histone acetylation leads to a more condensed chromatin449conformation that occludes the binding of transcription factor Y, thereby repressing transcription450from TSS2.451

In many situations discussed above, it is puzzling that the cell uses so many resources on synthe-452 sizing a translationally deficient mRNA. A possible explanation for this "unnecessary" energy con-453 sumption resides on the regulatory cis action of alternative transcription as discussed above. In S. 454 cerevisiae, aTSS usage driven by alternative promoters has cis regulatory activities, mostly via tran-455 scriptional activation. However, even if the RNA species produced from these aTSS are not cod-456 ing/translated, we cannot exclude that at least some may have additional trans regulatory activities. 457 In metazoans, several examples exist of trans-acting lncRNA acting on chromatin through binding 458 chromatin modifiers or remodelers [123]. Thus, it is possible that this regulatory activity could occur 459 in fungi as well. 460

Though not yet reported in yeast and fungi, several lines of evidence suggest the 461 involvement of DNA methylation in the regulation of aTSS usage in mammals. Cap-tar-462 geted and bisulfite genomic sequencing data reveal variation in methylation patterns 463 among alternative promoters of tissue-biased genes [124]. In human and viruses, the ac-464 tivity of alternative promoters is negatively correlated with hypermethylation of its CpG 465 islands [124-128]. In conditions in which demethylation of aTSS is observed, the active 466 promoter-associated histone modification H3K4me3 is detected spanning the promoter, 467 implying genuine transcriptional activities [124,125]. How DNA methylation and TFs in-468 terfere with each other, and impact promoter expression is still controversial. In the hu-469 man gene garp, an in vitro DNA-protein binding assay demonstrated an inhibitory effect 470of methylated CpG flanking the alternative promoter on the binding capacity of the 2 pos-471 itive transcriptional regulators NFAT and Foxp3 [124]. Thus, steric hindrance of the me-472 thyl groups associated with DNA methylation at alternative promoters can repress TF 473 binding to the corresponding cis-elements [129]. Conversely, TF binding can also affect 474 local DNA methylation patterns and induce transcription through passive demethylation 475 of the bound region [129,130]. Although cytosine methylation has been identified in at 476 least 16 yeast species [131], the impact of DNA methylation on transcription requires clar-477 ification in model yeasts and pathogenic fungi. 478

#### 5. Conclusions and remaining challenges

aTSS usage is a major mechanism regulating gene expression and proteome diversity 480in eukaryotes. Use of alternative promoters results in alterations in mRNA that can sig-481 nificantly modify transcript stability and translational efficiency, as well as protein se-482 quence localization and function. Thus, aTSS has a potential critical impact on cell growth, 483 differentiation, and adaptation. This type of regulation of both the transcriptome and the 484 proteome structure is still poorly studied in pathogenic fungi. However, data produced 485 in fungal model organisms, such as N. crassa, S. cerevisiae, and S. pombe, suggest that reg-486 ulation of gene expression via aTSS may be common in pathogenic fungi as well. Accord-487 ingly, genome-wide analysis in 2 species of Cryptococcus and in C. albicans identified sev-488 eral aTSS clusters associated with coding genes, although the regulation of their expres-489 sion and the associated molecular mechanisms remain to be explored [20,63]. Fungal path-490 ogens need to adapt to diverse conditions and efficiently produce virulence factors to es-491 cape the host immune system and potentially acquire drug resistance. This suggests so-492 phisticated and precise gene regulation mechanisms, such as aTSS usage, to regulate their 493 biology and virulence. 494

The analysis of aTSS usage in model organisms revealed a significant number of 495 multiple-promoter genes showing no promoter switch in different conditions. In this case, 496 it is possible that transcript isoforms are regulated under unknown conditions. They can 497 also be co-regulated. Cells uniformly express both alternative transcripts across condi-498 tions, but a population of cells could express a specific isoform while the alternative tran-499 script would be expressed in the other part of the cell population. In the latter scenario, 500 analysis of the whole population at once does not capture the true picture of aTSS usage 501 [132]. Thus, single-cell TSS analysis would allow more accurate findings. However, this 502 type of analysis is challenging in fungi. TSS likely plays major role in host-pathogen in-503 teractions given the heterogeneity of in vivo and in vitro fungal populations [133]. 504

	Overall, the handful of studies on aTSSs in pathogenic fungi suggest wide usage and	505				
	should prompt exploration of the mechanisms regulating the expression of virulence fac-	506				
	tors, drug resistance, or in vivo fungal cell biology. Although a limited number of se-	507				
	quence datasets have been produced, no genome-wide analysis of the regulation of aTSS	508				
	usage has been performed in any pathogenic fungi.	509
